NOTE ABOUT THIS REVISED REPORT: At the request of Video Division staff, this Q2 2012 KAZA-TV Form 398 is being refiled to correct inadvertent errors in the responses to Questions 8 (a) and 8(b). In Question 8(a), the total hours per week of programming aired on multicast streams was 336 hours (2 streams), rather than 504 hours (3 streams) as previously reported. In Question 8(b), the total hours per week of Core programming was 6 hours, rather than the 3 hours previously reported. As further instructed by FCC staff, a copy of the KAZA-TV Form 398 as originally filed is attached at Question 7(c), as proof of timely filing.
