The lead character is Stephanie, a young girl who guides the audience through the story as she and her friends ("human" puppets" and her Uncle (Mayor Milford Meanswell) navigate life within lazy Town. Robbie Rotten, the underground spy and influencer who personifies the ethos of lazy Town, is determined to ruin the health and fitness practices of Stephanie and her friends. When the kids have difficulty with Robbie Rotten, Sportacus (a gymnast/athlete prepared to answer call for help) come sot the rescue from his home in a eating "sports candy" (aka fruits and vegetables", always obtaining sufficient sleep, and going outside to engage in a wide range of physical activities that include playing games, competing athletically, and even building forts and play structures.

While in Treetopolis, Tom and his friends, Ariella, Twigs, Squirmtun and Zigzoo will invariably run into a problem or disaster that needs fixing. Tom calls upon the audience to practice original dance moves that will bring him 'Big World' magic so he and his friends can resolve their challenge of the day.
