On September 22, station KAQY's broadcast channel 11 went dark and the ABC signal it carried was migrated to KNOE channel 8.2. During this same time, station KNOE's 8.2 NNOE signal was migrated to KNOE 8.3. In addition to station KNOE's 3.4 hours, and station's KAQY & NNOE's hours of children's programming numerous public service announcements are aired each week aimed at children 16 years and younger regarding issues such as health and safety for kids, educational motivation and other topics for children including such issues as education, being good citizens, drug abuse prevention, etc.
