WITN has increased the total number of hours on Core Programming on channel 32.2 to six hours as a result of this activation. You may examine the WITN-TV public file for quarterly affidavits of public service announcements designed specifically for children that aired on WITN-TV and detailed weekly descriptions of program contents.
