KZMM-CD experienced a number of programming changes during this reporting period, including the addition on February 23 of a fourth stream of programming on 22.4. On February 9 the programming on 22.2 changed from 3ABN-Latino to Shop Q and as of February 10, no Core programming aired on 22.2. However, due to the many hours of Core programming on the primary stream and on the other secondary streams, KZMM-CD broadcast well in excess of the required 3 hours/week/channel of Core programming at all times throughout the reporting period. In addition to airing the Core programming as just described, the station aired public service announcements that had a significant purpose of educating and informing children (e.g., public service announcements related to children's health issues and the importance of education).
