In the December 2010 1st Quarter Report, the target age range for "The Magic School Bus" was misidentifed by NBC as 4-8. It has been corrected in this report as 7-9. WXIA offers additional children's educational programming during core hours as part of its universal sports programming on a digital multicast channel. On Jan 4. Universal Sports preempted a half hour of children's programming due to coverage of live alpine skiing that started at 11:30am. They moved it and mad it good on Thursday Jan. 6 from 11:00am to 11:30am. Effective 12/9, 11Alive Digital Weather began airing on WATL-TV, 36.2. The 11Alive Public File details quarterly PSA's and news programming targeted to children 16 and under in the Quarterly Issues/Program Report.
