In the imaginary setting of Lazy Town, characters' eating and fitness habits are linked to problem solving in their world. The lead character is Stephanie, a young girl who guides the audience through the story as she and her friends ("human" puppets) and her Uncle (Mayor Milford Meanswell) navigate life within Lazy Town. Robbie Rotten, the underground spy and influencer who personifies the ethos of Lazy Town, is determined to ruin the health and fitness practices of Stephanie and her friends. When the kids have difficulty with Robbie Rotten, Sportacus, a gymnast/athlete prepared to answer any call for help, comes to the rescue from his home in a zeppelin-like aircraft that hovers over earth. The underlying themes of Lazy Town stress the importance of eating "sports candy" (aka fruits and vegetables), always obtaining sufficient sleep, and going outside to engage in a wide range of physical activities including playing games, competing athletically, and even building forts and play structures.

Tom uses specific movements to summon up magic powers that permit him to morph into an animated hero and fly around in Treetopolis, the fantasy version of his woods. While in Treetopolis, Tom and his friends, Ariella, Twigs, Squirmturn and Zigzoo will invariably run into a problem or disaster that needs fixing. Tom calls upon the audience to practice original dance moves that will bring him "Big World" magic so he and his friends can resolve their challenge of the day. Educational messages reinforce positive socio-emotional content, with examples that model: being loyal to good friends, knowing how to ask for help, doing the right thing instead of what is convenient, making the effort to share rather than being selfish or relying on teamwork in order to accomplish a goal.

The Chica Show features a five-year-old "baby" chick who spends her days with her parents in their costume shop, the Coop. The shop's one employee, Kelly, doubles as Chica's nanny and the ensemble is rounded out with Bunji, a large floppy eared rabbit and Stitches, a straw mannequin that sits in the window. In each episode Chica develops or encounters a problem that she cannot immediately resolve. Usually her issues involve impulse control, distractibility, judgment, and inter-personal behaviors. She and Kelly usually work on the problem through an adventure-a fantasy transformation to animation-- where Bunji and Stitches come alive and join Chica and Kelly for the problem solving process. The core educational content is primarily socio-emotional development, and Chica learns how to express herself properly, think before she acts, and interact with others effectively. Show #611 The Community Affairs programming for NBC 5, Five Talk Street, aired on Sunday, April 12, 2015 at 11:30 am. In this program, we discussed the family friendly event, Earth Day Texas, which is sponsored by NBC 5 and Telemundo 39. The purpose of this outdoor event is to elevate environmental awareness and influence the way Texans live, think, and work. Discussed a juried arts festival, which is sponsored by the Southlake Women's Club called "Art in the Square." NBC 5 has been the television media sponsor of this event since it started and Bianca Castro was the emcee for the sponsored event that took place on April 24th, 25th, and 26th in the Southlake Town Square. This event is now nationally recognized as one of the top juried fine art festivals in the United States. Discussed the Nasher Sculpture Center in the Dallas Arts District and its family fun and art education activities. This includes the Target First Saturdays monthly series, which are the programs and activities offered the first Saturday of each month; and The Great Create with Meredith Land. This is a fundraiser that allows children to put their hands to work in engaging projects under the instruction of Dallas-based and national artists. This sold-out event raised more than \$100,000 last year. Discussed the 8th annual event of Silver Dollar at the Ranch. This event is aimed at raising much needed funds to support pediatric cancer initiatives of Speedway Children's Charities in the Texas Chapter at Texas Motor Speedway in the areas of Dallas, Tarrant, Collin, and Denton County. This year the event takes place at XO Ranch in Aubrey, Texas and the theme of the event is "The Stars at Night." NBC 5's Kris Gutierrez was the co-emcee of this event, along with our guest, attorney/television personality Dawn Neufeld.
