Busytown Mysteries I was reinserted at the end of the kids programming lineup. Promotional efforts were not made to notify the public because this was a last minute change due to technical problems. On Saturday 9/8/12 we had a problem with a sports feed we were supposed to take from CBS and took a kids feed instead. Busytown Mysteries I aired a second time from 10:00-10:30 AM and Busytown Mysteries II aired at 10:30-11:00 AM. No promotional efforts were made because this was a last minute change due to technical problems. On Saturday 9/22/12 the episode of Busytown Mysteries I from 9/8/12 aired an extra time at 8:00 AM due to a miscommunication about make goods. Some preempted children's programming was not rescheduled in its second home due to technical problems and due to extensive CBS Sports coverage during the US Open and college football.
