Golf ran long and the program was JIP'd at 3:46pm. On 9/29, Noodle & Doodle and Pajanimals were scheduled to air at 4:30pm and 5pm respectively. Due to Golf running long, these programs slid by 19 minutes and aired in their entirety.
