Our satellite antenna and receiver failed, which cut off delivery of all our children programs except Angel's Friends, which was delivered on DVD until mid-May, when the supplier stopped DVD delivery. We also had a program from a local children theater, but they suspended production because of their own internal considerations not involving WWCI. The engineer we normally use for repair the satellite had a heart attack and it took several weeks to find someone to do the work. It is now back in operation and we will be resuming 5 hours a week of children programming in the third quarter of 2011. For the first two quarters, our average is almost 3 hours a week and it will be more than hours average over the third quarters of 2011. |
