The July total was 40, the August total was 27 and the September total was 36. The :10 and :30 themes of these PSA's deal with the environment, tolerance, mentoring, and violence prevention. The More You Know's website (<a href="http://www.nbc.com/tmyk">www.nbc.com/tmyk</a>) features scripts from the award-winning public service announcements referral information for the organizations referenced in the PSA's, a general campaign over view, and educational materials produced in connection with NBC programming. The site also includes a list of the campaigns's most recent accolades. During the quarter, there were 14 news stories appropriate for children that aired on either the 5PM or 6PM newscast. The content of these stories ranged from...Middle school students are digging into history with an archaeology project in Franklin County...As temperatures climb, most kids are looking for ways to beat the heat. One of those ways may be the pool. Here's some safety tips that can make thehirs next swim a little safer...If you are planning on swimming anytime soon, it might be a good idea to keep a close watch on your child's ears. Doctors say during the summer there is an increase in the number of patients with swimmers ear. Kids Cast - every Wednesday during our 5PM newscast weather segment, a third to fifth grade school student gives out weather forecast. Children draw a picture of "Weather" and submit it to our local Kids Cast sponsor. Each week, a picture is chosen, and the child that drew it sits in on our live news set and delivers the local weather. The child arrives early and in addition to learning about the weather, they get to see how a live newscast works "behind the scenes". During the month of April 61 30-second promos aired for the WHAG Student Athlete of the Month. During the month of May 61 promos aired, and during the month of June 61 promos aired. The community nominates the students. Then each month, a male and female athlete is chosen for their outstanding efforts in the classroom and on the field. A feature story is done on each winner and airs within the local news. Congratulations promos air during the following month. On July 20, Bryan Tolle Meteorologist, went to the City Park Bandshell, Baker Park, Frederick MD. He spoke to about 150 children, ages 2-5 years old, about his job at WHAG. He also talked about science and the environment. On August 15, 1st United Day Care, Mercersburg, PA toured the station. They toured the news room, studio, control room, and weather center, where the meteorologist told them about predicting the weather. On August 24, a group from Girls Inc. toured the station. There were 15 girls, ages 6 to 18. They toured the news room, control room, studio and weather center. Hugh Breslin, VP and General Manager is on the Advisory Board of the Mason Dixon Boy Scouts.</p>
