Main Digital: Lazy Town encourages fitness and healthful habits for preschool children. In the imaginary setting of Lazy Town, characters' eating and fitness habits are linked to problem solving in their world. The lead character is Stephanie, a young girl who guides the audience through the story as she and her friends ("human" puppets) and her Uncle (Mayor Milford Meanswell) navigate life within Lazy Town. Robbie Rotten, the underground spy and influencer who personifies the ethos of Lazy Town, is determined to ruin the health and fitness practices of Stephanie and her friends. When the kids have difficulty with Robbie Rotten, Sportacus, a gymnast/athlete prepared to answer any call for help, comes to the rescue from his home in a zeppelin-like aircraft that hovers over earth. The underlying themes of Lazy Town stress the importance of eating "sports candy" (aka fruits and vegetables), always obtaining sufficient sleep, and going outside to engage in a wide range of physical activities including playing games, competing athletically, and even building forts and play structures.

On Aug 9th, Noodle and Doodle was pre-empted by NBC breaking news, coverage of a presidential announcement concerning air strikes in Iraq. News ran from 10:30 to 10:56A. On September 14, the station launched a new 24/7 program stream. The new stream was on the air 2 weeks during the quarter, so the station has reported 336 in item 8(a). For 11 weeks during the quarter, the station aired 168 hours per week of multicast programming.
