The Commission should not that due to programming line-up changes during the final week of the quarter, two shows on our non-primary streams, Aqua Kids and Swap TV, were replaced by Whaddyado and BIZ Kids respectivly. The same holds true for our primary stream programming. Due to scheduling changes by the CBS network, our Saturday and Sunday shows were replaced the final week of the quarter by new CBS Children's shows. Our Saturday shows, Doodlebops I & II and Busytown Mysteries I & II are being replaced by Lucky Dog, Dr. Chris Pet Vet, Recipe Rehab, and Jamie Oliver's 15 Minute Meals in that order. Our Sunday shows, Liberty's Kids I & II are being replaced by All in With Laila Ali and Game Changers With Kevin Frazier, in that order. Effective July 15, COOLTV was dropped from 18.2 and Weather Radar moved from 18.3 to 18.2 on that date. As of 7/15, D3 was shut down, affecting the weekly averages for secondary streams.
