As a result of technical issues, WMOW's This-TV program stream (including its regularly scheduled children's core television programs) did not air on channel 4.3 on November 23 and 24, 2013. In an effort to comply with the station's children's core television programming obligations, WMOW simulcast its CW+ program stream (including its regularly scheduled children's core television programs) on channel 4.3 on November 23-24.
