Section 73.670, with respect to these programs. In reference to Question 8: the station began airing THISTv Network on digital sub-channel 23.3 on March 2, 2011. A 3 hour block of Children's E/I Programming is provided Saturdays 10AM-1PM. A copy of THISTv Network's Commercial Limits and Website Rule Compliance Certification for this quarter has been placed in the Public File. Due to a failure of the network-wide graphics box, which is responsible for keying in the "E/I" logo over all children's educational programming, THIS Network children's educational programs which aired on Saturday and Sunday March 23-24, 2013, did not contain an "E/I" logo superimposition throughout the entirety of the programs. Each of those programs were identified by the Network as an "E/I" program to the suppliers of program guides, and were introduced by an announcement stating that the following program is an "E/I" program. However, due to the graphics error, the "E/I" logo failed to appear as a superimposition over each of the programs for the full duration of all program segments. THIS Network has informed us that this inadvertent error has been corrected. In addition, those same program episodes were rebroadcast in their respective second home on the following dates and times listed below. Those rebroadcasts were publicized by announcements on THIS Network and the "E/I" logo was superimposed over each of the seven (7) programs for the entire program during those rebroadcasts. "Busy World of Richard Scarry" #40 was rebroadcast Saturday, 3/30 from 1:00-1:30pm. "Wimzie's House" #104 was rebroadcast Saturday, 3/30 from 1:30-2:00pm. "Wimzie's House" #105 was rebroadcast Saturday, 3/30 from 2:00-2:30pm. "Country Mouse, City Mouse" #24 was rebroadcast Saturday, 3/30 from 2:30-3:00pm. "Danger Rangers" #113 was rebroadcast Saturday, 3/30 from 3:00-3:30pm. "Doodlebops Rockin' Road Show" #126 was rebroadcast Friday, 3/29 from 10:00-10:30am. "Doodlebops" #312 was rebroadcast Sunday, 3/31 from 11:00-11:30am. The station terminated analog operations on February 17, 2009. Accordingly Questions 2-6 are no longer applicable.
