On 06/11/11 Magic School Bus/302-8AM, Babar/208-8:30AM and Turbo Dogs/118-9AM did not air due to a power failure on our transmitter site, KBLR subsecuently rescheduled the programs and gave on air notices as noted on the preemption reschedule report.</p>
