WNCT non broadcast efforts include the participation of Anchors and Meteorologists as guest speakers and emcees for community groups. Station tours are conducted for Scouts, churches, and schools for children of all ages. During the tours and station visits meteorologists explains various aspects of the weather, including words like humidity, temperature and how satellites and computers are used to forecast the weather. They also express the importance of science and math to those interested in becoming a weather forecaster. During the quarter, WNCT invited Classrooms from 3rd to 8th Grade to sign up and ask questions and submit classroom photographs that could be used in the weather broadcasts on WNCT-TV 9 and on wnct.com. The Storm Team Students program includes free educational handouts, a chance to learn about weather safety and weather mythology from around the world. WNCT now has a network of 10 weather stations placed in Middle Schools throughout the viewing area called Storm Net 9.
