After review of internal and station records and documentaion provided to us by the program suppliers the licensee hereby certifies as follows: (i) the only programs specifically designed for children ages twelve and under that the station broadcast this quarter are disclosed in this report, and (ii) the licensee fully complied with the FCC commercial limits, as specified at 47 C.F.R. section 73.670 with respect to these programs. NOTE ABOUT THIS REVISED REPORT: At the request of Video Division staff, this Q1 2012 KAZA-TV Form 398 is being refiled to correct inadvertent errors in the responses to Questions 8(a) and 8(b). In Question 8(a), the total hours per week of programming aired on the multicast streams was 336 hours (2 streams), rather than 504 hours (3 streams) as previously reported. In Question 8(b), the total hours per week of Core programming was 6 hours, rather than the 3 hours previously reported. As further instructed by staff, a copy of the KAZA-TV Form 398 as originally filed is attached to this resubmission at Question 7(c), as proof of timely filing.
