WOWK-TV PRE-EMPTIONS: During the period August 9,2014 through September 27, 2014 the two 30-minute core programs regularly scheduled for broadcast Saturday mornings at 9 AM and 9:30 AM were rescheduled to other core hour slots and to their "second home" slots when possible in most instances the following day during the core hours 7:00 AM and 7:30am, in order to carry a time-sensitive weekly pre-game talk show featuring locally venerated West Virginia University Mountaineers college football head coach Dana Holgorsen; in the licensees good faith judgment, the rescheduling best served the needs and interests of the viewers of the West Virginia-based station during the time slot, in the public interest. During the period August 30,2014 through September 27, 2014 the two 30-minute core programs regularly scheduled for broadcast Saturday mornings at 10 AM and 10:30 AM were rescheduled to other core hour slots and to their "second home" slots when possible, in order to carry a time-sensitive weekly one hour pre-game show, Mountaineer Game Day,featuring live reports prior to kickoff of the WVU Mountaineers college football team,in the licensees good faith judgment, the rescheduling best served the needs and interests of the viewers of the West Virginia-based station during the time slot, in the public interest.
