The Pajanimals are a group of four preschool aged puppets who live together in house with their off-screen mother and father. We meet them in the bedroom, a dormitory of sorts, where they show us their nighttime routine of brushing their teeth and having quiet conversation before falling off to sleep. The quiet time, always turns into a discussion that results in a dream-like adventure to solve a problem, such as overcoming shyness, making a new friend, or dealing with a bully. The adventure takes place in several nighttime dream locales where special friends help them work through the socio-emotional problem of the day. Specific approaches to managing the problem are demonstrated and practiced during the adventure, and the children return home confident, getting ample rest for today and facing their issues tomorrow.

He begins with a problem that vexes him and daydreams his way into an adventure that takes him to different places around the world, but also provides him with an experience that helps him solve his problem when he returns home. While on the adventure he is accompanied by Olive, a knowledgeable imaginary playmate, and Squidgy the morphing flying sponge, who provides commentary and comedy along the way. Justin's lessons involve learning, for example, that it takes focus to achieve success, failure can teach what we need to do to succeed next time, or when one path to solve a problem doesn't work, you can find another way to get to your goal. The lead character, Stephanie, guides the audience through the story. She and her best friends, a group of "human" puppets reside in Lazy Town, where her uncle is the Mayor Milford Meanswell. The underground spy and influencer who define the ethos of Lazy Town is Robbie Rotten, and he is determined to ruin the health and fitness practices of Stephanie and her friends. When the kids get into difficulties with Robbie Rotten, it is Sportacus, gymnast/athlete who comes to the rescue from his home in a spaceship that hovers over earth, prepared to answer to any call for help. The ever-present theme of Lazy Town is to eat "sports candy" which consists of fruits and vegetables, get sufficient sleep, and go outside and engage in a wide range of physical activities, from playing games, holding athletic competitions, to building forts and play structures.</p>

The episode was scheduled for make-good at 12pm but was not in the server to air at its rescheduled time at 12pm. The operator played PSA's and eventually another program due to the amount of time already loss, approx. 15 minutes into the half-hour. The program had been promoted to air at 12pm. Once the operator got the program in the system, "Noodle and Doodle" aired at 1:00pm following another scheduled E/I kids program. Channel 56.2 was off the air due to technical difficulties beginning on Saturday 7/28/12 at approx. 4:00am through Sunday 7/29/12 at 1:46pm. Therefore, "Profiles of Nature" did not air at 7:00am on Saturday. Due to network programming constraints we are unable to make-good this episode. NBC Network Non-Broadcast Efforts include The More You Know Website. "The More You Know's" comprehensive website(<a href="http://themoreyouknow.com">themoreyouknow.com</a>) provides in-depth referral information, in connection with the on-air public service announcements. The program aired on 7/14 /12 at 7-9pm. Description: McKenna is a fourth-grade gymnast in the Seattle area who has trouble with reading comprehension.
