KELO-LAND TV has placed 29 weather forecasting and measurement instruments in area schools. The systems include curriculum on CD-ROM for school students. Information from these is used during our newscasts making mention of the school location we are using. The first 8 systems were donated by KELO-LAND TV. Additional systems are purchased by the schools or donated by area businesses. KELO-LAND TV also has a weather net van. The Live Doppler Weather Net Van, Dorothy, is a weather station on wheels. The Live Doppler HD Weather Team goes to schools and organizations all over KELO-LAND to help students and viewers understand weather. They demonstrate how our weather team works together with each other and state-of-the-art technology to keep viewers informed.
