As a result, the station has been silent since early September and has been operating under an STA to remain silent because of hurricane damage. WQQZ has been off of the air for the entire quarter and no programming has aired during this time. This includes childrens programming. Beginning August 1, 2018, WQQZ-CD will be back on the air on channel 24 in Puerto Rico and will resume its childrens programming.
