Subsequent to the initial filing of the report, the licensee was advised by SonLife Broadcasting Network that, due to a technical error which has since been corrected, the E/I bug did not appear on screen during 1 hour of this "rescheduled" E/I programming, "Generation of the Cross" on Saturday, March 31, 10:00 AM. As the error occurred on the last day of the quarter, a makegood episode was scheduled to air on Saturday, May 12, 2018 and will be included on the 2Q 2018 report.
