As the Commission's files reflect, the station normally airs 6.5 hours per week of core children television programming, or 84.5 hours per quarter, on its primary digital channel. However, during this quarter the station aired its preemptive bi-annual telethon which reduced the station's quarterly children programming to 76.7 hours which is still 37.7 hours more (76.7 vs. 37.7 hours) for its primary digital channel as required by Commission Rule 73.671 (Note 2). Furthermore the station aired 94.50 hours per week of additional core children's television programming, or 1229 hours for the quarter on its two digital sub-channels. This represents 1121 hours, on average, above the 108 hours of additional children's television programming per quarter specified by the Commission in this circumstance.
