Because station WBXH ceased analog operations and converted to digital-only operations prior to the start of the reporting period, Questions 7(b) and 7(c) are no longer applicable. On October 10, the Escape Network experienced technical difficulties that resulted in the first hour of the block to be preempted and the remaining two hours to experience a start time delay of 9 minutes. One show from the first hour and one show from the second hour were made good as non-core programming on October 18.
