In the imaginary setting of Lazy Town, characters' eating and fitness habits are linked to problem solving in their world. The lead character is Stephanie, a young girl who guides the audience through the story as she and her friends ("human" puppets) and her Uncle (Mayor Milford Meanswell) navigate life within Lazy Town. Robbie Rotten, the underground spy and influencer who personifies the ethos of Lazy Town, is determined to ruin the health and fitness practices of Stephanie and her friends. When the kids have difficulty with Robbie Rotten, Sportacus (a gymnast/athlete prepared to answer any call for help) comes to the rescue from his home in a zeppelin-like aircraft that hovers over earth. One or more episodes of children's programming that was preempted during the quarter was not rescheduled. The Digital Core Programming Summary section of this report would not permit the station to include preemption reports for such unrescheduled preemption's, and FCC Staff has advised that no preemption report for such unrescheduled episodes is necessary. On February 27, 2016, WEEK-TV's entire building lost power as a result of a construction project. As a result, the children's core program Astroblast that was scheduled to air from 10:30 -11:00 AM was preempted in its entirety, and the children's core program Clangers was jointed in progress halfway through. Because the circumstances behind the preemption we beyond the control of the station, the station is treating the preemption like a breaking news preemption, and it is included in the core programming average in the Digital Core Programming section of this report.</p>
