On May 5, 2017, the station requested special temporary authority to operate at reduced effective radiated power (ERP), which was granted on ____ On June 17 ,2017, WMEI's satellite programmer rearranged the feed coordinates, however the station was not notified on time. As a result, both stations were without a satellite feed from June 17 to the morning of June 20, and no programming was aired during this time. The amount of CORE hours reflected on this report includes only the periods when the station was operating, and does not include any days that the stations were silent or unable to air programming..
