Viewers were notified in advance to ensure an appropriate on-screen environment for the youth audience during the broadcast of children's shows. Three hours of the pre-empted block were made good on Sunday, September 3rd from 1:00pm-4:00pm. Programming alerts ran periodically throughout our coverage notifying viewers of the program change. The following programs were made good on 9/3 at the following times: 1:00pm Jack Hanna's Into the Wild 1:30pm Ocean Treks with Jeff Corwin 2:00pm Sea Rescue 2:30pm The Wildlife Docs 3:00pm Rock the Park 3:30pm Outback Adventures with Tim Faulkner. Saturday, 8/26/17: Children's programming was pre-empted from 9:00am-11:00am for live, breaking news coverage of Hurricane Harvey. Sunday, 9/3/17: "Teen Kids News" moved to Sundays at 12:30pm as of Sunday, September 3, 2017. On-air crawls and ID's ran in advance of this program change to notify viewers. Sunday, 9/10/17: "Teen Kids News" was pre-empted for live, breaking news coverage of Hurricane Irma. 4th Quarter: Saturday, 10/7/17: "Vacation Creation with Tommy Davidson & Andrea Feczko" begins on 10/7 at 11:30am in place of "Outback Adventures." This program change was originally noted as beginning 9/30; however, the program syndicator revised the premiere date to the weekend of 10/7.
