The Digital Core Programming Summary section of this report would not permit the station to include preemption reports for such unrescheduled preemption's, and FCC Staff has advised that no preemption report for such unrescheduled episodes is necessary. It is not immediately apparent from the information in this report that, on Multicast Channel 8.2, several shows were preempted on September 9 by live sports coverage and rescheduled to their second homes on September 10. Subsequently, on September 10, live breaking news coverage of Hurricane Irma preempted the rescheduled episodes from their second homes.
