But Pete Sepenuks narrative tone and style light and fascinated matches and holds the attention of the target audience. And once it holds attention, what On The Spot does very well is deliver excellent informational content. And for the target audience, it is essential that the information is not dumbed down. It is not in On The Spot.
