Sunday, October 21 and Sunday, November 18, Teen Kids News was pre-empted due to ABC sports programming. On Saturday, December 15, core programs Jack Hannas Wild Countdown, Ocean Treks with Jeff Corwin, The Great Dr. Scott 1st Half Hour, and The Great Dr. Scott 2nd Half Hour were preempted from their regularly scheduled times at 9AM, 9:30AM, 10AM and 10:30AM to air Breaking News coverage of the Funeral Proceedings of fallen local hero, Worcester Fire Fighter Christopher Roy. The late breaking nature of his passing and fluid nature of the schedule of his funeral service were beyond the control of the station, and it was not practicable to reschedule the programs. 1st Quarter Notes: Beginning on Saturday, January 5, the Litton Weekend Adventure line up will include Rescue Heroes at 10am replacing The Great Dr. Scott 1st Half Hour. Also beginning Saturday, January 5, Teen Kids News moves to Saturdays at 12:00pm, until further notice. On-air crawls and ID's did run two weeks in advance to notify viewers of the program changes. One or more episodes of children's programming that was preempted during the quarter was not rescheduled.
