In partnership with local business, we provided tickets to the Lamar Cardinal Football games. We supplied the Art Museum of SETX AMSET a Reporter for a Day package to raise money for the Childrens Museum. We participated in the Youth Solutions Career Day, sponsored by Region V and attended by high school juniors and seniors throughout our viewing area.
