This was one of the largest academies with more than 300 students and family members present. The talk of the town these days is the proposed 70 million dollar confluence project (performing arts/retail/housing) for downtown Eau Claire. The city council and county board have both voted to put varying referendum questions on the April ballot. WQOW has done a number of major projects looking at the project, the questions and its January 28, Meteorologist Andrew McCawley led a station tour of cub scouts. Lisa Patrow and Jerry Gallagher are working with the Chamber to host a candidate WQOW was a sponsor of the Wisconsin Classic ice fishing contest held on Lake Wisconsin. WQOW was a sponsor of Karaoke for a Cure which raises money for the American Cancer Society. Keith Edwards was the emcee. On Friday, February 7th, Nick Grunseth led a group of five homeschool students and parents on a tour of WQOW-TV. On Tuesday, February 11th, the 5th grade class from St. Joseph's Catholic School in Menomonie visited WQOW News 18 for a tour. Tuesday and Wednesday, Feb. 11 and 12, Meteorologist Andrew McCawley led tours of Cub Scouts. On Wednesday, February 12th, Meteorologist Nick Grunseth visited Messiah Lutheran School in Eau Claire to talk to fourth, fifth and sixth graders. About 50 students attended an assembly in the afternoon. On Wednesday, February 19, News 18 held a Weather Academy at the Eau Claire public library open to any and all students in the district. The WQOW mets and news team continue to provide extraordinary coverage our winter weather. We have surpassed the coldest winter on record for Eau Claire and are on pace to break the record for the "snowiest" on record. March 4, WQOW was a co-sponsor of a candidate forum in the race for Eau Claire City Council President. The event was well attended and extremely important given the looming confluence project and subsequent referendums on the spring ballot. Jerry Gallagher was the moderator. We also live streamed the event on our website. Heidi Solin replaces Jerry Gallagher on the board for the Eau Claire Children's Museum. Amie Winters replaces Jerry Gallagher in our Tools for Schools program. Thanks to the addition of a second sponsor we will now be offering \$500 awards instead of \$300. We had a nice lunch with our Jefferson Awards committee and chose our delegate for Washington, D.C. The 2013 cycle of winners was the best yet. We are seeing some high quality nominees. February 23, WQOW was a sponsor of the Polar Plunge for Special Olympics. We had a team jump and staff members that acted as judges. WQOW also provided booth judges for the Home and Garden Show on February 21. We are gearing up for WIAA. Once again, Bob Bradovich will be doing play by play, we will be sending shooters to Madison and Green Bay along with our Internet Director. Our vignettes are almost complete. On February 26th, 2014, Chief Meteorologist Nick Grunseth visited Thorp Catholic School in Thorp, WI to talk to about elementary school students about weather. He covered severe weather safety, discussing what to do in the event of a tornado, severe thunderstorm, flooding, and extreme cold and heat. WIAA boys and girls state basketball wrapped up with a first ever state title for one of our local teams! Lots of news and sports coverage preceded and followed on the small city of Thorp! The broadcast went very well, WQOW's Bob Bradovich did a superb job and our coverage both on air and online was appreciated by many viewers!
