WWHO continued its sponsorship of Thursday Night Lights, the broadcast of local high school football games live on its air. This promotes children's involvement not only in athletics, but also in academics, as student scholar athletes are celebrated during the broadcast. It also gives the highlighted schools and its students a sense of community. In addition, WWHO participated in the annual Toys for Tots drive in the community, encouraging viewers to drop off new, unwrapped toys for underprivileged children at local retail establishments and at the station. WWHO also airs a series of PSA's designed to teach children about the world around them, including respecting the environment, the dangers of drugs and alcohol and the importance of family values.
