The lead character is Stephanie, a young girl who guides the audience through the story as she and her friends ("human" puppets) and her Uncle (Mayor Milford Meanswell) navigate life within Lazytown. Robbie Rotten, the underground spy and influencer who personifies the ethos of Lazytown, is determined to ruin the health and fitness practices of Stephanie and her friends.
