The new line-up featured DOODLEBOPS 1 at 10:00 AM, DOODLEBOPS 2 at 10:30 AM, DANGER RANGERS at 11:00 AM and HORSELAND at 11:30 AM. Crawls promoting these changes were broadcast during Children's programming on September 3, 10 and 17. Information regarding this schedule change was also provided to TV Guide and The Washington Post. The September 3rd episode of HORSELAND 1 was pre-empted by CBS Sports coverage of US Open Tennis. This program was rescheduled for August 27 at 12 NOON. That broadcast was pre-empted for breaking news and rescheduled again and aired on September 17 at 7:00 AM. The September 3rd episode of HORSELAND 2 was also pre-empted by CBS Sports coverage of US Open Tennis. This episode was rescheduled and aired on September 17 at 12 NOON. Crawls promoting these changes were broadcast during Children's programming on September 3, 10 and 17. On August 28, CBS coverage of US Open tennis was scheduled to pre-empt THIS WEEK IN DEFENSE NEWS at 11:00 AM and THE MCLAUGHLIN GROUP at 11:30 AM. Both programs were rescheduled to air on August 28 from 7:00 to 8:00 AM. That move displaced two children's programs JACK HANNA'S INTO THE WILD and ANIMAL EXPLORATION WITH JAROD MILLER. Both children's programs were rescheduled and aired on August 27 from 7:00 to 8:00 AM. Information regarding this change was listed on the WUSA website and broadcast during WUSA newscasts on August 25 and 26. Breaking news coverage of Hurricane Irene pre-empted WUSA's Public Affairs Block of PLATT'S ENERGY WEEK, BIO-CENTURY THIS WEEK, CBS NEWS SUNDAY MORNING, FACE THE NATION, THIS WEEK IN DEFENSE NEWS and THE MCLAUGHLIN GROUP on August 28th from 8:00 AM to 12 NOON. WUSA moved this entire block of programming to its digital multi-cast channel thereby displacing the regularly scheduled Children's programs that normally air from 9:00 AM to 12 NOON. Those Children's programs were rescheduled and aired on the digital multi-cast channel August 30th in their second home from 10:00 AM to 1:00 PM.
