Even during this quarter when the station aired its preemptive bi-annual telethon the station's quarterly children's programming was 60 hours which is still 21 hours more (60 vs. 39 hours) for its primary digital channel as required by Commission Rule 73.671 (Note 2). Additionally, the station aired 94.8 hours per week of additional core children's television programming, or 1233 hours for the quarter on its three digital sub-channels. This represents 1116 hours, on average, above the 117 hours of additional children's television programming per quarter specified by the Commission in this circumstance. One of the digital sub-channels, the LaFuente channel, ceased operation at noon on September 23rd due to network cancellation on the channel.
