WFXG was taken off the air due to a severe ice storm on 02/14/2014 that caused the preemption of Real Life 101, (Program 5 in question 10). The sole episode of Aqua Kids, (Program 11 in question 10), was due to a E/I time change from 7:30am to 7:00am which will be the new home for E/I programming. WFXG plans to air additional core programming in 2nd quarter to average out the shortfall from 1st quarter.
