After due review of the internal station records and documentation provided to us by program suppliers, the licensee hereby certifies as follows: (i) only the programs specifically designed for children ages twelve and under that the station broadcast this quarter are disclosed in the report and (ii) the licensee fully complied with the FCC's Commercial Limits in children's programs, as specified at 47 C.F.R. Section 73.670, with respect to these programs. The E/I symbol did not appear on the KICU (DT2) program TV Kindergarten until 9/5/14.
