WSTM-NBC3 is committed to age-appropriate experiences and enrichment for Central New York children. Second Quarter saw staffers involved in station tours for area students (including from Moravia and East Syracuse Minoa High Schools). We also continue to do station tours for younger students, especially scouts working on communicator badges and beads. Job shadows are longer and more intense experiences, aimed at helping students decide on careers: This quarter we hosted a middle school student from Roberts School in Syracuse, several Jordan-Elbridge High School Students (part of the Partners for Education and Business outreach) and also with Aurora of Central New York's Pre-Vocational Workshop (we were commended by the New York State Commission for the Blind). We show our business, but also emphasize good work habits and workplace readiness. Our college-level interns also wrapped up their semester-long work with us, shadowing reporters, producers and sports staffers. In addition, our staffers give of their time as volunteers on community boards that provide education and services to children, including the Museum of science and Technology, the Challenger Field of Dreams, and the Salvation Army/Syracuse area.
