The following Qubo episodes were affected and made-good in their 2nd HOME on 6/4/11 from 12P-2P: Turbo Dogs (TDO117), Shelldon (SHL012), The Magic School Bus ("The Magic School Bus In The Arctic"), and Babar ("The Missing Crown Affair"). On Sunday, June 5, the NBC's coverage of French Open Tennis continued, pre-empting Willa's Wild Life (WIL008) and Pearlie (PEA107). Both of these episodes were made-good in their 2nd HOME on 6/11/11 at 12P & 12:30P. On Sunday, June 12, WGAL aired the Annual Children's Miracle Network Telethon to raise funds for Penn State Hershey Medical Center & Children's Hospital. The Telethon pre-empted Willa's Wild Life (WIL005) and Pearlie (PEA103); both of these episodes aired on 6/11/11 at 12P & 1:30P. "The More You Know" comprehensive website (www.themoreyouknow.com) complements the on-air public service announcements, while providing in-depth referral information for viewers. Content includes video of all current public service announcements, a general campaign overview, message borands, press releases, kids' pages and referral information by topic to partnering agencies referenced in the PSAs. The site includes a comprehensive list of the campaign's accolades, including Emmy and Peabody Awards. In addition, a behind-the-scenes story with clips from talent interviews can be viewed. Brain Busters is a locally produced high school quiz-bowl show that airs on Saturdays at 12:30pm on WGAL. This 30-minute quiz-bowl tournament is geared towards high school students and celebrates academic achievement; it began airing on WGAL in January 2000. The broadcast tournament includes nearly 40 schools from Lancaster, Lebanon, Dauphin, Cumberland, Perry, York, Franklin and Adams counties. Schools compete for school funding for scholarships, prizes, and more!
