Those episodes of The Suite Life of Zack and Cody that air on ABC as Core Programming deliver life lessons tailored for the older child and tween audience. Stories take place in a luxury hotel in Boston, where twelve-year-old identical twins Zack and Cody live with their divorced mom, a lounge singer for the Tipton Hotel. The boys attend a local public middle school. One of the twins is polite and shy and excels in academics, while the other, athletic and extroverted, barely scrapes by in school, due to lack of effort. He often instigates wacky plans for outwitting hotel authorities, caregivers, and their mother. The boys mother dates and would like to remarry. Their father is a professional rock musician who is on the road much of the year, but stays in touch with his sons. This sets up occasional parental conflicts about discipline and expectations. JANUARY 1 PREEMPTIONS: On January 1, 2011, the following programs were preempted in order to carry network broadcasts of the Tournament of Roses parade: On the station's main digital stream, "The Magic Schoolbus," a 30-minute core program which regularly airs Saturdays at 11 AM, was rescheduled to January 2, 2011, at 1 PM, a core time slot. On the station's digital multicast stream, the 30-minute core programs "Hannah Montana," which regularly airs Saturdays at 11:00 AM, and the Suite Life of Zach and Cody, which usually airs at 11:30 AM, were rescheduled to their "second home" Sunday time slots, on January 8 at 12:00 PM and 12:30 PM respectively, which are also core time slots. These were one-time preemptions to carry network parade coverage of great interest to the community. Promotional efforts were made to notify the public of the rescheduled dates and times of the preempted children's programs, by notifying program guides and viewers. Therefore, it is respectfully submitted that the rescheduled core programs should continue to count toward the station's three-hour average, consistent with "Preemption of Children's Television Educational and Informational Programming," 8 CR 1036 (M. Med. Bur., July 11, 1997).
