KOAT airs AD COUNCIL public service announcements during Children's Programming and other Public Service Announcements during different dayparts. Some recent education topics include staying in school, reading programs, energy conservation, parental involvement and health related announcements. Other announcements focus on children's health issues such as tips on obesity, skin cancer prevention, dental hygiene, pre-natal care, child abuse prevention, seat-belt safety for children, and fire safety. KOAT even produced a children's psa with Dr. Barry Ramo, called the Ramo Rap, that teaches children about prevention of the H1N1 Virus. KOAT's community outreach campaigns are designed to address the issues affecting New Mexico's youth. The campaigns deliver positive, action-oriented messages and reports, stressing what each adult, as a parent, neighbor, or member of the community can do to help children overcome the obstacles that inhibit their growth and learning potential. Our news department regularly covers stories targeting parents and their children. Among these are "Research Rocks", a news segment that features local students and encourages students to excel in science and mathematics. Community outreach projects include KOATs for Kids (provides coats for children who cannot afford them), and KOAT School Supply Drive(a school supplies drive providing pencils, paper and folders to children who cannot afford them.
