Q13 Fox First Forecast Channel (powered by AccuWeather) is carried on digital channel 13.2. Different episodes of DRAGONFLY TV and SWAP TV aired on the secondary channel 13.2 than aired each week on KCPQ's primary channel 13.1. On 6/13 & 6/14 for 13.2, Dragonfly TV and Swap TV show files became corrupted/unairable, and it was impossible to obtain suitable copies in time for scheduled airdates (or re-air by week's end). Two extra/unique episodes of core program Edgemont aired in their place on 6/13 & 6/14 at 2:00p on 13.2. Since program corruption was not learned until day of air, we were unable to publicize these changes in advance. The station has taken remedial measures to avoid recurrence of this problem in the future.
