The current licensee, One Love Outreach, Inc., only recently acquired the license for the station, on May 6, 2010, pursuant to a Commission grant of an assignment of license, File No. BALCDT-20100122ACQ. It is unable to provide information as to the programming broadcast prior to the time that it became the licensee. Upon closing, the station immediately suspended operations temporarily and has sought Special Temporary Authority to remain silent, File No. BLSTA- 20100608AEE. Accordingly, since the time at which the current licensee acquired the station, no programming of any type, including no children's programming, has been broadcast. The licensee currently is actively making plans to return the station to the air.
