WVIR-TV also provides round-the-clock live weather updates on a secondary digital stream (digital 2). We encourage parents to use all of these opportunities to help children keep up with current events and how these events shape our world. 2) WVIR-TV broadcast 296 youth-targeted (ages 16 & under) PSAs furnished by NBC on the primary digital stream during 4th Quarter 2011. 3) Additionally, during 3rd and 4th Quarters, we aired a total of 1420 PSAs for the UVA Children's Hospital, in lieu of our annual Children's Miracle Network telethon. (The telethon was withdrawn at the hospital's request this year.) 4) Upon request, we offer tours of the television station to students, clubs, and scout troops; and one of our weathercasters makes visits to outlying schools to discuss meteorology and science. We average 2-3 tours/visits per month. 5) In October, one of our morning news anchors participated in "Read for the Record," an annual event in which she visited a kindergarten class and read books to the students.

The main character, Shelldon, is an orphaned yoka shell mollusk adopted by the Clam family and living with them in the family-owned Charming Clam Inn. Dr. Shell, an elder and venerated inventor, and Connie, a cowrie shell classmate of Shelldon's also live at the Inn. Shelldon and his buddies, Herman (a hermit crab) and Connie (a cowrie shell), always work together and solve problems that they face in school or in the community. A recurring problem is to staunch the plans of the local millionaire, Cecil Cracken, whose greed puts making money over protecting the environment. Dr. Shell is typically the children's key provider of knowledge and other resources. In each episode, the children learn a significant social-emotional lesson and also share information relating to their ocean habitat and environmental protection.
