Describe the educational and informational objective of the program and how it meets the definition of Core Programming.	"Lazy Town" encourages fitness and healthful habits for preschool children. In the imaginary setting of Lazy Town, character's eating and fitness habits are linked to problem solving in their world. The lead character is Stephanie, a young girl who guides the audience through the story as she and her friends ("human" puppets) and her Uncle (Mayor Milford Meanswell) navigate life within Lazy Town. Robbie Rotten, the underground spy and influencer who personifies the ethos of Lazy Town, is determined to ruin the health and fitness practices of Stephanie and her friends. When the kids have difficulty with Robbie Rotten, Sportacus, a gymnast/athlete prepared to answer any call for help, comes to the rescue from his home in a zeppelin-like aircraft that hovers over the earth. The underlying themes of Lazy Town stress the importance of eating "sports candy" (aka fruits and vegetables), always obtaining sufficient sleep, and going outside to engage in a wide range of physical activities including playing games, competing athletically, and even building forts and play structures.

The shop's one employee, Kelly, doubles as Chica's nanny and the ensemble is rounded out with educational and Bunji, a large floppy eared rabbit and Stitches, a straw mannequin that sits in the window.
