On November 3 and November 10, 2013, a few episodes of "Zoo Clues" that aired on the station's This-TV multicast stream featured an E/I logo that was not completely visible as a result of network issues. As a result of technical issues, WAOW's This-TV program stream (including its regularly scheduled children's core television programs) did not air on channel 9.3 on November 23 and 24, 2013. In an effort to comply with the station's children's core television programming obligations, WAOW simulcast its CW+ program stream (including its regularly scheduled children's core television programs) on channel 9.3 on November 23-24. The information provided above in Section 10 of this report accurately reflects the children's core programs that actually aired during the weekend of November 23-24, including those that aired on both channel 9.2 and 9.3 during that weekend. On Sunday, December 8, 2013, due to technical difficulties, Animal Science, Great Big World, and Live Life & Win did not air in its entirety. On December 15, 2013, as a result of a network error, the two episodes of "On The Spot" that aired in their regularly scheduled time slot ran without the E/I logo. Consequently, those episodes were made good in their second homes on December 29, 2013, with the E/I logo properly displayed.
