Section 73.671, NOTES 2 and 3. | <p>On 11/1/14 from 9:30a-9:32a Ocean Mysteries was interrupted with a Severe Weather update and then on 11/1/14 Sea Rescue was interrupted from 10:00a until 10:02a due to a Severe Weather update as well. Both programs were then joined in progress. The Children's Television Act and the FCC's rules require that programming targeting children ages twelve and under may not contain more than 10.5 minutes of total commercial matter per clock hour on weekends and no more than 12.0 minutes of total commercial matter per clock hour on weekdays.
