It aired on Saturday 2/22 at 6:00-6: 30pm and Saturday 3/1 at 1:00-1:30pm on D1. Another locally produced program, "N Beat," celebrated the accomplishments of Chicago's Latino community. "N Beat" aired on Saturday 3/22 at 6:00-6:30pm and Sunday 3/23 at 2:30-3:00pm on D1. We also aired "Windy City Live: Inside The Mind: Mental Health Awareness." The show takes a hard look at mental illness and suicide and aired on Monday 2/10 at 11:00am-12:00pm and Tuesday 2/11 at 12:05-1:05am, also Monday 2/10 at 12:00-1:00pm on our D.2/D.3 channels.
